## **CLOCK HOUR REQUIREMENTS: 1600**

Can be completed by a full-time schedule of 30 hours per week for 53.5 weeks, or with a part-time schedule of 20 hours per week for 80 weeks.

### **Full Time Schedule:**

30 hours a week for 53.5 weeks  
**12.5 months Minimum**  
Tuesday—Friday 9:30am-5:30pm

### **Part Time Schedule:**

20 hours a week for 80 weeks  
**18.5 months Minimum**  
Tuesday—Friday 5:30pm -8:30 pm  
Saturday 8:30am – 5:00pm

### **Absences:**

Students may miss up to 160 hours but must maintain 85% in attendance at all times. After exceeding the 160 hour limit, they are charged an hourly rate of \$11.50 for every hour missed.

## **REGISTRATION DEPOSIT:**

In order to register for a class start date you must complete the steps of enrollment and pay the registration deposit of \$150.00 to Federico Beauty Institute. This payment includes the \$20.00 locker deposit. Acceptable payment methods include cash, check, money order, bank check and credit cards (except American Express). If you do not pay the deposit, a spot is not held for you in the class.

### **Pivot Point On-Demand Learning!**

**Externship Program (Except VA):** at completion of 960 clock hours, 10% of hours can be earned in local salons/spas.

**Pre-application to State Board:** at completion of 1200 clock hours, students can pre-apply to guarantee an exam date as early as 2 weeks after graduation. If students do not pre-apply, there is a 6 week- 6 month wait.
